COVID 19 Notice, Assumption of Risk, Limited Waiver
Limited Purpose: *Pride and Prejudice* Auditions, May 2021

The unique characteristics of COVID 19, including its potential for transmission by infected individuals who are asymptomatic, require a community-wide commitment to mitigate the transmission of COVID 19. County Players has put in place health and safety procedures and protocols consistent with the recommendations of the Center for Disease Control (“CDC”), along with other federal, state, and local authorities.

Your cooperation is essential in our efforts to mitigate the transmission of COVID 19, including screening, social distancing, and the use of face masks and, if applicable, gloves. Failure to follow County Players’ protocols may lead to your removal from County Players during the COVID 19 national emergency. Even with health and safety protocols in place, there still is a risk that an individual may contract COVID 19.

Accordingly:

- I acknowledge my role in following the protocols of County Players, while I participate, as I am responsible for my role in limiting the spread of COVID 19 to other participants.
- I acknowledge that despite County Players’ compliance with CDC and other federal, state, and local guidelines and recommendations, County Players cannot limit all potential sources of COVID 19 infection; accordingly, I assume the risk of contracting or being exposed to COVID 19, while auditioning for *Pride and Prejudice*.
- County Players is a not for profit community theatre. I am under no obligation to participate in the County Players at any time, including during the national health emergency pertaining to COVID 19. I am volunteering to be involved in County Players with the role/purpose of auditioning for *Pride and Prejudice*.
- I hereby waive and release County Players, its trustees, officers, and agents, from any claims I may have now or in the future arising from (i) my exposure to and infection from COVID 19; (ii) County Player’s efforts to mitigate the spread of COVID 19; and (iii) any effect COVID 19 and/or County Player’s mitigation efforts may have on my health. This waiver and release does not release County Players from any negligence claim where County Players is found to be solely liable.

By signing below, I acknowledge the risk involved with Covid-19, my role in mitigating the spread of COVID 19, and that I could still be exposed to COVID 19, despite the mitigation efforts of County Players. I am voluntarily participating with County Players. I assume all risk associated with COVID 19 and release County Players from all claims relating to COVID 19 as per the waiver above.
